

Transitional Regulations - From 112 BBA 2013 to 114 BBA 2017, from 113 BBA 2013 to 115 BBA 2017 and 130 BSc 2013 to 131 BSc 2017

25 April 2017

Preamble

These Transitional Regulations apply to some small improvements and amendments in the curriculum of the following programs: Bachelor of Business Administration in Tourism and Hospitality Management; Bachelor of Business Administration in Tourism, Hotel Management and Operations; and Bachelor of Science in International Management.

For organizational reasons, changes to the curricula will be reflected in the following amended study program numbers:

- Bachelor of Business Administration in Tourism and Hospitality Management, from version 112 BBA 2013 to version 114 BBA 2017;
- Bachelor of Business Administration in Tourism, Hotel Management and Operations, from version 113 BBA 2013 to version 115 BBA 2017; and
- Bachelor of Science in International Management, from version 130 BSc 2013 to 131 BSc 2017.
- § 1 At the commencement of the Fall semester 2017, all new Undergraduate students will enrol in one of the following, 114 BBA 2017, 115 BBA 2017, 131 BSc 2017.
- § 2 The study regulations of 112 BBA 2013, 113 BBA 2013 or 130 BSc 2013 will remain in place until the end of the Spring semester 2018, and courses will continue to be offered until the end of the Spring semester 2018.
- § 3 Students who cannot complete all necessary courses within 112 BBA 2013, 113 BBA 2013 or 130 BSc 2013 by the end of the Spring semester 2018, will be transferred to 114 BBA 2017, 115 BBA 2017 or 131 BSc 2017 respectively. Necessary courses do not include the Bachelor Thesis and Internship components and, where necessary, students will be permitted to complete these components in an additional semester.
- § 4 Students will be required to submit a written declaration, in an approved form, to the Academic Office declaring a) transition into 114 BBA 2017, 115 BBA 0217, or 131 BSc 2017, or b) all necessary courses can be completed by the end of the Spring semester 2018.
- § 5 No fees will apply to changes arising from the abovementioned curriculum changes in the respective study programs. However, the completion of ECTS in excess of the requisite ECTS for the study program i.e., 180 or 240, associated with additional Enrichment courses, will remain in effect as outlined in MU's Guidelines on Fees as defined and announced by the University Board.
- § 6 Changes to the curriculum of the study programs are outlined in the course equivalency overviews at § 7(1) (3):





(1) Upon application the Dean may grant equivalency subject to individual assessment. The requirement to submit a bachelor thesis for students in 114 BBA 2017 and 115 BBA 2017 may be substituted by a minimum of three (3) approved enrichment courses.
